The 78th Annual Meeting of the Michigan Educational Credit Union was called to order by President and CEO, Robert Sandercock, at 7:00 P.M. on Wednesday, April 22, 2020. Due to the COVID-19 pandemic and the restrictions on public gatherings, the meeting was conducted in a virtual setting. There were 93 people in attendance comprised of members, board, and staff. The virtual Annual Meeting was hosted by Robert Sandercock, President and CEO, and consisted of a business format that fulfilled our regulatory obligations according to the bylaws of Michigan Educational Credit Union.

President and CEO, Robert Sandercock, established a quorum for the meeting.

Robert Sandercock welcomed everyone to the WebEx meeting and thanked everyone for taking the time to join.
